#### Note:

- Food and Accommodation charges of Rs.42,000/- per semester will be charged separately.
- From the Caution Deposit, Rs.3000- will be refunded after successful completion of the Course, if there is no damage to the physical entities of the University and Rs.2000- would be retained towards registration fee for SVYASA Lifetime Alumni Association Membership.
- Once the payment is made and the receipt is obtained and if the candidate discontinues the course in between, then the amount of refund depends on the refund policy of the university.
- The Examination Fee and Convocation Fee will be collected separately before the examination as notified by the Controller of Examinations, time to time.
- The above fee structure holds good for candidates from SAARC nations also.
- After 3 years the registration fee is Rs. 15,000/- per semester.
